Job Description:

Title: Various job openings (JRF / SRF / RA-II / RA-III) to work in a project to develop “**Neutral Atom based Quantum Computing platform**”. **The project is supported by National Quantum Mission, an initiative by DST, Govt. of India.**

Nature of the work:

Selected candidates are expected to work in a team, with Scientists / Technologists / Professionals to develop state-of-the-art facilities for Quantum Computing. The work involves handling / operating lasers, optics, precision electronics, and analysis of scientific data, programming, project management and preparing scientific manuscripts, presentations and similar activities.

Desirable:

The candidates are expected to have prior knowledge of Quantum Computing with neutral atoms, and/or some exposure to experimental techniques in the same or related fields.

Institute invites applications from Indian nationals for the following positions purely on temporary and contractual basis under funded project titled “Quantum Computing” under National Quantum Mission (NQM).

- 4) The prescribed date for determining the upper age limit, educational qualifications or experience shall be the last date for submitting applications.
- 5) The prescribed educational qualification should have been obtained from recognized Universities / Institutions.

- 6) The prescribed educational qualification/s are the bare minimum and mere possession of same does not entitle candidates to be called for interview. Where number of applications received in response to this advertisement is large, it may not be convenient or possible to interview all the candidates. The Project Investigator may restrict the number of candidates to be called for the interview to a reasonable limit after taking into consideration minimum educational qualifications and experience over and above the minimum prescribed in the advertisement.
