Bank reserves the right to cancel or modify the selection criteria, results etc based on the court's final order.

As per Interim order dated 12.02.2026 passed in WP(C) No. 14589 of 2020 passed by the Hon'ble High Court of Kerela, the selection of one vacancy out of total 19 vacancies earmarked for Kerela shall not be filled without obtaining further order from the Hon'ble High Court of Kerela.

Candidates are advised to visit the Bank's website periodically to check further notifications / instructions, if any. Decision of the Bank in all matters pertaining to selection process shall be final and binding. This notification shall be treated as intimation to all the candidates, who have applied for the position.
