In pursuance to the Notification dated: 31.08.2021 cited at (Ref-1) recruitment process to fill up 80 posts of Police Constable (Civil) (Men & Women) and 20 posts of Sub-Inspector of Police (Civil) (Men & Women) including In-Service and Kalyana-Karnataka was initiated by adhering all the procedures laid down in the Cadre and Recruitment Rules, After the recruitment process this office published Provisional Select List for the above posts cited at Ref-2.
