- Applicant must have secured at least 40% marks in the qualifying examination i.e. in ITI.
- Mobile number on e-Aadhaar downloaded from website of UIDAI shall be same number used for registration on NAPS portal.
- A candidate can apply for only one trade in either West Bengal or Jharkhand. If a candidate applies for both West Bengal and Jharkhand, their application will be rejected.
- Successfully clears document verification.
- Candidates must comply all these criteria to be eligible for engagement as APPRENTICE.

2. ENGAGEMENT PROCEDURE FOR ITI:

- I. Application (in the prescribed format) with all necessary enclosure must be sent to - **The office of the General Manager, HRD, Dishergarh, Paschim Burdwan, WB, 713333 either by speed post or registered post so as to reach on or before 26th September, 2025.** Application form shall be dully filled in and complete in all respect. **Application submitted before the date of notification of this advertisement and after 26th September, 2025 will be rejected. Application must be sent by registered or speed post. Application send through courier or by hand will not be considered.**
- II. A merit list will be prepared based on marks obtained in qualifying examination. If two or more applicants secure same marks in qualifying examination then preference will be given to the candidate Who have passed qualifying examination earlier (year of passing). If year of passing of the qualifying examination is also same, then date of birth shall be used for tie breaker. Older candidates shall be given seniority. If Date of Birth of two candidates are also same, then candidate who registered earlier on NAPS portal shall be senior. Reservation as applicable for CPSU shall be followed.
- III. Based on merit, candidates will be called for document verification. A notification will be published in this regard on ECL website.
- IV. After successful document verification, candidates will be given training engagement letter indicating place of posting and date of reporting at the place of posting and also scheduled date for contract creation at HRD, ECL HQ.
- V. Candidates must join at their respective place of posting on the date as mentioned in the engagement letter.
- VI. After joining at their respective place of posting, a joining letter will be issued to the candidate from their place of posting.
- VII. Candidate must report to HRD office again with the copy of joining letter for creation of contract on portal on the date as mentioned in their engagement letter.
- VIII. Place of Apprenticeship Training shall be decided by the General Manager (HRD), ECL.
