QUALIFICATION

Graduates with at least two years full time Post Graduate Degree/ Post Graduate Diploma / Post Graduate Program in Management with specialization in Human Resource / Industrial Relations / Personnel Management or Masters in Social Work or MHROD or MBA with specialization in HR from recognized Indian University/ Institutes (recognized by appropriate statutory authority) with not less than 65% marks, as per respective university/institute norms.

AGE LIMIT

Max. 29 years as on last date of online application.

Selection Process:

1. Eligible candidates will have to appear for All India based Online Selection Test. The online selection test will have two parts i.e. Subject Knowledge Test (SKT) & Executive Aptitude Test (EAT). The candidates are required to qualify both in Subject Knowledge Test (SKT) and Executive Aptitude Test (EAT), separately.
2. Based on merit and requirement of the post; candidates will be short listed for Personal Interview/ GD and Personal Interview both. All shortlisted candidates after written test will have to secure minimum qualifying marks in Personal Interview/GD and Personal Interview, as applicable.

Test Centers:

Candidates have to choose any two cities as preference-1 and preference-2, as Test Center and no change in any circumstance will be considered subsequently. However, NTPC reserves the right to cancel or add any center depending on the response of the candidates for that area / center.

COMPENSATION PACKAGE:

Selected candidates will be placed in the **pay scale (IDA) of Rs.40,000-1,40,000 at the basic pay of Rs. 40,000/- (E1 Grade)**. The other benefits such as Dearness Allowance, other perquisites and allowances, terminal benefits, etc. will be admissible as per company rules in force from time to time during training / after absorption.

PLACEMENT:

The selected candidates shall undergo one-year training at various places. The final place of posting will be decided after completion of training. Candidates can be placed, across the country, in any of the projects/ stations including Subsidiaries/JVs companies of NTPC.

RESERVATIONS AND RELAXATIONS:

1. Candidates claiming to belong to any particular category shall necessarily have a valid EWS/OBC-NCL/SC/ST/Disability certificate, as the case may be, from the Competent Authority. Reservations and relaxations for SC/ST/OBC/XSM/EWS/PwBD (degree of disability 40% or above) candidates will be provided as per Government guidelines. **Relaxations will be extended in vacancies identified for SC/ST/OBC/PwBD category.**
2. Category (SC/ST/OBC/EWS/PwBD) once filled in the online application form will not be changed and no benefit of other category will be admissible later on.
3. Where there is vacancy identified for such category, SC, ST and PwBD candidates with at least 55% marks in qualifying examination are eligible to apply for the post. The upper age limit is relaxed by 5 years for SC/ST, 3 years for OBC (Non-Creamy Layer) candidates. It is relaxed by 10 years for PwBD-General/EWS, 13 years for PwBD-OBC(NCL) and 15 years for PwBD-SC/ST candidates. The OBC candidates who belong to "Creamy Layer" are not entitled for concession admissible to OBC category and such candidates have to indicate their category as General. The EWS/ OBC (Non-Creamy Layer) candidates are required to submit requisite certificate in prescribed format of Government of India, from a competent authority **issued in the current year only**. In addition, the age relaxation for Ex-servicemen (XSM) will be as per Government of India norms.

SERVICE AGREEMENT BOND:

The selected candidates who belong to General, EWS and OBC categories will be required to execute a service agreement bond of Rs. 5,00,000/- (Rs. 2,50,000/- for candidates belonging to SC, ST, PwBD categories) to serve the company for at least 3 years after successful completion of one-year training.

HEALTH:
